**GENERAL CONDITIONS:**

1. The No. of Posts indicated above is provisional and may vary depending upon requirement. Reservation of posts for SC/ST/OBC/Ex-Servicemen will be as per Government of India directives. Candidate has to submit the relevant caste certificate in proper format.
2. The cut off date for age will be 30.09.2015. Age for General category is 40 Yrs. (Relaxable upto 5 Yrs for SC/ST, 03 Yrs for OBCs (Non Creamy layer) and as per Govt. of India guidelines for Ex -Servicemen).
3. Persons with Disability means a person suffering from not less than 40% (Forty Percent) of disability as certified by Medical Board/Competent Authority duly constituted by Central or State Govt. A disability certificate in the prescribed format issued by Medical Board/Competent Authority for the purpose of employment must be enclosed along with application form.

4. The selection of the above post will be through written test & other test, if required and interview.
5. Candidate may note that merely qualifying in the written test & other test (if required) and interview will not entitle a candidate for appointment.
